1. Introductions

4. Finances and Treasurer's Report – Eric Pitcher

From Eric Pitcher

Since the start of the calendar year, total revenues amounted to \$117. The division's 2020 allocation to support student travel to the national meetings was not used because the meetings were conducted virtually. The division was given the option of having the funds held over to support future travel or have it returned to the division, and we chose the latter. We spent \$184 on plaques. Taking all revenues and expenditures into, the division showed a surplus of \$1,933, resulting in a fund balance of \$31,913.

Staci Levy also provided the division with the AAD scholarship fund report. The fund started 2020 with a balance of \$40,496. Two \$1000 scholarships were awarded (to Charles McSwain and Noah Higgins), and over the calendar year 2020, the investment gains were \$6253 (15.44%). ANS Board of Directors took \$4253 from the fund to leave it with a policy approved by the Board in 2014, where investment gains exceeding scholarship distributions are transferred to the ANS general fund, buy-in years where there are investment losses or gains insufficient to cover the awarded scholarships, shortfalls are taken from the scholarship fund. As a consequence of this 2014 change in policy, the AAD scholarship fund has eroded from \$47,325 in 2014 to \$40,496 today.

5. AccApp Conference Series

AccApp'21 updates - From Lin Shao

Currently, the submission portal is open. Invitation of speakers is about to be finalized. Several sessions have been filled quickly, such as materials sessions. The plenary talk speakers will be determined next week. We have some delays, mainly due to the fact that everyone waits for ANS on the decision on whether it will be in person or hybrid.

Things are accelerated now. The organization committee is optimistic that the meeting will be successful.

For the meeting itself, AccApp will have three rooms. One room has the capability of two-way video like true virtual presentations. The other two rooms will be for in person presentations. However, these two rooms will be allowed to play pre-recorded videos, plus question sessions through chat.

All plenary sessions will be in the room equipped for virtual presentation. Plenary sessions will be in the morning. It is planned at this point, the morning of the last day will be a plenary session as well to maximize the numbers.

We have encountered a problem with the publications. ANS journal nuclear science and engineering refuses to accept four-page manuscripts and insists that all accepted papers should be 10 pages above. Therefore, we may invite only about 15 papers to develop into journal papers. The number of 15 is the limit from the journal publisher. For all others, 4-page papers will be published through conference proceedings. For those who plan to publish long papers but are not included into the special issue for AccApp, it is the plan to encourage them to submit as a regular particle with page charge covered by the conference.

For speakers who will present a pre-recorded video because of room restrictions, the registration fee is unclear at this point.

We encourage all presenters, including in person attendants, to upload a pre-recorded video so all attendants can view them later.

IAEA will support \$5000 for the travel support.

Back to the budget, we have \$10k from Texas A&M and \$55K from NNSA. Because of the publication plan change, we may save money, and we are checking how much can be transferred to the division account.
